












INDIA'S CRUDE OIL IMPORTS HIT 12-MONTH LOW



The import of crude oil by India, the world's third-largest importer, hit a 12-month low of 17.80 million tonnes (MT) in September this year largely on account of lower requirement due to autumn refinery maintenance and lower consumption during monsoons.

According to the Petroleum Planning and Analysis Cell (PPAC), crude oil imports on a provisional basis declined by 5 per cent M-o-M, but were higher by 6 per cent on an annual basis.

According to Vortexa, India bought around 4.196 million barrels per day (mb/d) of crude oil, which is the lowest in FY24. The decline was partly compensated by lifting more cargoes of Iraq's Basrah, which is also a medium sour grade similar to Urals and preferred by Indian refiners. Russia accounted for 38 per cent of total imports.

OPEC in its monthly oil market report had said that India's crude imports are expected to be lower in September, as the monsoon season curbs domestic needs, before picking up in October as the start of the festival.



LEGAL UPDATES

UNSTAMPED ARBITRATION AGREEMENTS ENFORCEABLE, RULES 7-JUDGE SUPREME COURT BENCH



Overruling its earlier April judgment that ruled to the contrary, a seven-judge Supreme Court Constitution bench on Wednesday unanimously held that unstamped arbitration agreements are legally enforceable and any arbitration clause in an unstamped or insufficiently stamped agreement is also enforceable and such a defect is curable and does not render the contract invalid.

By 3:2, the majority verdict on April 25 had ruled that an arbitration clause is void and

not enforceable in law if the agreement is unstamped or insufficiently stamped. It had held that an arbitration agreement cannot be separated from the main contract, and if stamp duty was not paid properly on the main contract, the arbitration clause is also invalid. The ruling raised concerns about potential delays in arbitrator appointments and clashed with India's pro-arbitration stance.

Setting aside the April verdict, the larger seven-judge bench led by Chief Justice DY Chandrachud ruled that agreements that are not stamped or insufficiently stamped are not rendered void or void ab initio or unenforceable if arbitration agreement prima facie exists between parties. The apex court held that the issue of unstamping cannot be gone into at the stage of Section 8 or Section 11 (at the start of arbitral proceedings) as it goes against the rationale of the law.

According to the judgment, the agreements without the proper stamping were not automatically void or unenforceable as – they just couldn't be used as evidence, but it is a curable defect in the law.

Parties who have entered into an arbitration agreement will be relegated to an arbitration after examining the prima facie existence of an arbitration agreement. The arbitrator is competent to decide on all issues of jurisdiction including the enforceability of the substantive rights basis the validity/admissibility of an unstamped document.

The draft policy, drawn up by the State's investment promotion agency Kerala State Industrial Development Corporation on behalf of the Department of Industries and Commerce can be accessed.

After obtaining the views and suggestions, the submitted draft policy will be to the Government for approval. The policy is expected to be finalized and notified January 2024.



HEADLINES OF THE DAY

- > The United States and India have agreed to resolve their last outstanding dispute at the World Trade Organization on import restrictions on poultry products from Washington with New Delhi
- > Despite a rise in exports of petroleum products in September there was a reduction in value terms because of falling crude prices.
- > The move to provide credit at interest rates that are lower than the market rate comes at a time when Indian exporters are facing a serious challenge on account of slowing demand in key markets amid record inflation and the threat of a global recession.

INDIA CONTINUES TO EXPLORE ALTERNATIVES TO COUNTER CBAM IMPACT ON EXPORTS

Ahead of the second round of regulations related to EU's Carbon Border Adjustment Mechanism (CBAM) coming in, Indian officials discussing reportedly are two probable alternatives, which will factor in the carbon tax to ensure that exports are not hit. The first option officials are discussing suggest that an amount equivalent to the levied carbon tax on exports from India be negotiated factored into the final price of a finished product (using the said exported item) coming in from European Union nations, or on some items of similar nature.

paying carbon tax of \$100 per tonne, then price negotiations must be done to have another \$100 per tonne added to another item coming in from the EU. Officials told businessline that "this is not a countervailing tax on EU", but will be price negotiations to see that "tax collected from Indian companies be brought back to the country".
