












## CAN INDIA CHECKMATE CHINA IN THE POWER PLAY BATTLE FUELED BY IMPORT

The three largest air forces in the world, US Air Force (USAF), PLA Air Force (PLAAF), and the Russian Air Force (VVS), already have their home-grown fifth-generation fighters. Many other modern air forces have inducted the Lockheed F-35 and are working on sixth-generation aircraft, individually or in joint ventures.

India, the fourth-largest force and fifth-largest economy, is still at the Light Combat Aircraft (LCA) Mk1 stage. India's fifth-generation fighter, the Advanced Medium Combat Aircraft (AMCA), could take nearly 7-8 years to fly and almost 15 years to induct, or even more. In India's neighborhood, an immediate threat is China, and it already has 150 Chengdu J-20 "Mighty Dragon."

Their second fifth-generation fighter Shenyang FC-31 "Gyrfalcon," is being accelerated. China no more needs to import fighter aircraft. India is the only major country that could still be a possible buyer of a fifth-generation aircraft.



## LEGAL UPDATES

### CENTRE SETS UP PANEL LED BY FORMER LAW SECY T K VISHWANATHAN TO RECOMMEND REFORMS IN ARBITRATION LAW



Amid a push for making India a hub for international arbitration, the government has set up an expert panel led by former law secretary T K Vishwanathan to recommend reforms in the Arbitration and Conciliation Act with an aim to reduce the burden on courts. Attorney General N Venkataramani is also part of the expert committee set up by the Department of Legal Affairs in the Union law ministry.


Law ministry additional secretary Rajiv Mani, some senior advocates, representatives of private law firms, and officials of the Legislative Department, Niti Aayog, National Highways Authority of India (NHAI), railways and Central Public Works Department (CPWD) are its other members. According to the terms of reference for the committee, it will evaluate and analyse the operation of the present arbitration ecosystem of the country, including the working of the

Arbitration Act, highlighting its strengths and weaknesses and challenges vis-a-vis other important foreign jurisdictions.

The panel has to submit its report within 30 days, the office memorandum issued on Wednesday stated.

The committee has also been asked to recommend a framework of model arbitration system which is efficient, effective and economical and caters to the requirements of the users.

The panel will also devise strategy for developing a competitive environment in the arbitration services market for domestic and international parties that can subserve the interests of the users, particularly in building a regime of costeffective arbitration.



- > India's export subsidy programmes, such as the Export-oriented Units Scheme and sector-specific schemes, have also caused tension between the two nations.
- > India and the world were dealing with the first tide of Covid-19 and the Prime Minister had announced a countrywide lockdown

# INDIA CONTINUES TO EXPLORE ALTERNATIVES TO COUNTER CBAM IMPACT ON EXPORTS

Ahead of the second round of regulations related to EU's Carbon Border Adjustment Mechanism (CBAM) coming in, Indian officials reportedly discussing probable alternatives, which will factor in the carbon tax to ensure that exports are not hit. The first option officials are discussing suggest that an amount equivalent to the levied carbon tax on exports from India be negotiated and factored into the final price of a finished product (using the said exported item) coming in from European Union nations, or on some items of similar nature.

paying carbon tax of \$100 per tonne, then price negotiations must be done to have another \$100 per tonne added to another item coming in from the EU. Officials told businessline that "this is not a countervailing tax on EU", but will be price negotiations to see that "tax collected from Indian companies be brought back to the country".
