

GOVERNMENT HAS STARTED RUPEE TRADE WITH NEIGHBOURING COUNTRIES

Rupee trade mechanism has been initiated to facilitate trade in national currency with Russia. As of July 2, RBI has approved 34 applications from different Russian banks for opening SRVA in 14 Indian commercial banks," the minister said in a written reply.

The government has started trade in the rupee with neighbouring countries, including Nepal and Bhutan, Parliament was informed today.

Replying to a question in the Lok Sabha, Minister of State for Commerce and Industry Anupriya Patel said a significant part of the India-Nepal trade is being carried out in Indian Rupee (INR) and all bilateral trade with Bhutan is also transacted entirely in INR.

"Rupee trade mechanism has been initiated to facilitate trade in national currency with Russia. As of July 2, RBI has approved 34 applications from different Russian banks for opening SRVA in 14 Indian commercial banks,"



the minister said in a written reply.

RBI has issued guidelines for opening Special Rupee Vostro Accounts (SRVA) by foreign banks in Indian commercial banks. She said Sri Lanka has included INR in its list of designated foreign currencies.

Authorised dealer (AD) banks in India have been permitted to open rupee vostro accounts.

Legal Updates

Bombay High Court dismisses appeal challenging jurisdiction in view of Section 42 of Arbitration Act...

An appeal was filed challenging an order dated 26-04-2023 wherein it was held that the Court does not have jurisdiction to entertain the commercial Arbitration petition. A division bench of Devendra Kumar Upadhyay, CJ., and Arif S Doctor, J., dismissed the appeal and directed the appellant to move the present Commercial Arbitration Petition before the Principal District Court Thane within a period of four weeks from the date of order. The Appellant is a Cooperative Housing Society who had, in the year 2015, invited tenders for civil structural repairs etc. Thereafter an Agreement was entered into with the Respondent for the said work at Navi Mumbai. All the disputes and differences between the parties were deemed to have arisen in Navi Mumbai. A civil miscellaneous application was filed under Section 9 of Arbitration and Conciliation Act, 1996. An objection as to the jurisdiction of the Principal District Judge, Thane was taken by the Appellant, however, the said application was disposed of on merits by an order dated 03-02-2017 and the application was not dismissed on the grounds of lack of jurisdiction. Subsequently, the Respondent filed an Arbitration Petition under Section 11 of the Arbitration Act which was disposed of by an order dated 06-12-2018, observing that "the venue of the Arbitration shall be at Navi Mumbai." The Arbitrator passed an award stating "as directed by the Hon'ble High Court, all the meetings, except two, were held in Navi Mumbai. Due to some unavoidable circumstances, two meetings were held in Mumbai, with the consent of both the parties in the matter." The award was challenged by the commercial arbitration petition and the impugned order was passed. Counsel for the

appellant submitted that the place of arbitration as determined by the Arbitral Tribunal was Mumbai and thus the commercial arbitration petition was correctly filed in the Court. He stated that the seat/ place was Mumbai by relying on Section 31(4) of the Arbitration Act which mandates that the Arbitral Award must inter alia state its date and the place of Arbitration. It was also submitted that once the place/seat of arbitration had been determined, all applications had to be made only to the Court having justice.



NEPAL WANTS EASY ACCESS TO INDIAN MARKET TO EXPORT IN BULK AND ON LONG-TERM BASIS

The Nepal government on Friday said it wants to export tomatoes in bulk and on a long-term basis to India but for that, it needs to have easy access to the market and other necessary facilities.
