






# GOVT EXEMPTS ADVANCE AUTHORISATION HOLDERS & EOUS FROM QCOS

The government announced an exemption for advance authorization holders and export-oriented units (EOUs) from mandatory Quality Control Orders (QCOs) for imported goods used as inputs for exports, on Friday.

The exemption will be subject to pre-import conditions, with the inputs required to be utilized in the manufacturing of export products.

"Enabling provisions are made for exempting inputs imported by Advance Authorisation holders and EOUs from mandatory Quality Control Orders (QCOs)," the Directorate General of Foreign Trade (DGFT) stated in a notification.



Mandatory Quality Control Orders (QCOs) are essential for regulating product quality, preventing unfair trade practices, and safeguarding consumers and the environment. They apply to both domestic and imported products, requiring compliance for sale in the domestic market.

The government aims to expand QCOs to cover more products, improving the quality landscape in the country and offering consumers high-quality products.








#### RODTEP BENEFITS EXPANDED TO BOOST EXPORTERS

Commerce and Industry Minister Piyush Goyal introduced a range of initiatives focused on streamlining the export framework for export-oriented units, functioning within special economic zones or engaged in authorisation advance scheme, on Friday.

He announced an extension of benefits under the Remission of Duties and Taxes on Exported Products (RoDTEP) scheme.





Goyal highlighted encouraging growth trends in India's exports, with a slight decrease in goods exports offset by a rise in services exports.

Reforms include a revamped eBRC scheme for export proceeds, with RoDTEP benefits extended to certain entities.

An outreach program aims to boost e-commerce exports among small artisans and other sectors.




