



DGFT GRANTS EXEMPTIONS ON THE IMPORT OF THE QUALITY CONTROL ORDERS

DGFT exempts certain goods, like viscose staple fibre and steel items, from quality control orders (QCOs) for duty-free import under the advance authorisation scheme for use in export products, not for the domestic market. Initially granted for Ministry of Steel and DPIIT QCOs, the exemption now extends to Ministry of Textiles QCOs.

The Ministry of Commerce and Industry decided against a blanket exemption from QCOs for import of input goods after a meeting on January 10.



A recent notification exempts specific ministries' imported input goods from QCOs under the advance authorization scheme, aiding exporters facing supply issues. The exemption comes with safeguards and aims to boost textile exports.

Various QCOs have been published by different ministries since 2020 to regulate imports and ensure quality. The advance authorization scheme requires exporting incorporated goods within 18 months; unutilized goods must be destroyed with penalties.


INDIA'S DEFENCE EXPORT TO RISE TO RS 40,000 CRORE IN 2 YEARS : ANURAG THAKUR

Union Minister Anurag Thakur highlighted India's focus on increasing defense capabilities, with current defense production at one lakh crore rupees and defense exports at sixteen thousand crore rupees.

The aim is to raise exports to forty thousand crore rupees in the next two years.






