

INDIA EMERGES AS TOP CHOICE FOR SWEDISH BUSINESSES EYEING ASIAN EXPANSION

With Swedish companies seeking to shift their focus away from China in the Asian markets, India has risen as a favored destination for Swedish business investments, said Sweden's ambassador to India, Jan Thesleff.

"While numerous Swedish companies maintain operations in China, they exhibit a desire to diversify their presence across Asia. India emerges as one of the favored choices, with Swedish firms establishing manufacturing facilities and expanding their business activities in the country," Thesleff told Mint.



Sweden's business climate survey highlights India as a positive market for Swedish companies with significant FDI sectors inflows. Key attractina investments include automobiles and SAAB's machinery. investment in manufacturing in India strengthens defense ties. Bilateral trade faces challenges, but Sweden aims to enhance cooperation through export credits.

Thesleff views the proposed India-EU free trade agreement as crucial, anticipating a growing Indian population in Sweden by 2030.






