# INDIA-EFTA TRADE AGREEMENT TO BOOST GEMS & JEWELLERY EXPORTS

In a recent announcement, Vipul Shah, Chairman of the Gem & Jewellery Export Promotion Council (GJEPC), unveiled the promising future of India's gems and jewellery sector following the Trade and Economic Partnership Agreement (TEPA) between India and the European Free Trade Association (EFTA).

According to Shah, this agreement is poised to revolutionise the export landscape, particularly to EFTA member countries comprising Switzerland, lceland, Norway, and Liechtenstein.



Indian export figures of USD 335 million are expected to triple to USD 1 billion with the TEPA pact, focusing on gems and jewellery.

The agreement eliminates customs duties on Chapter 71 products, offering duty-free access to EFTA nations and reducing duties on various items.

This strategic pact fosters bilateral trade, enhances market access, and promotes growth in the gems and jewelry sector, benefiting India's export revenue and global presence.






