





INDIA SET TO BECOME EXPORTER OF FORGED RAILWAY WHEELS AFTER DECADES OF IMPORTS

Union Minister of Railways Ashwini Vaishnaw announced on Thursday that construction has begun on a new plant in Tamil Nadu to manufacture forged wheels for Indian railways.

The facility is a joint venture between the Indian Railways and Ramakrishna Forgings Ltd, with an investment of Rs 650 crore in the first phase.

For over 60 years, India has been an importer of forged wheels used in railways.



India is transitioning to exporting forged railway wheels, aiming to produce 2.5 lakh wheels annually with a focus on global exports.

The country's Integral Coach Factory is working on standard gauge Vande Bharat trains for export markets. The process involves designing, testing, and approvals, taking around 5 years.

India's ambition is to become a major exporter of rolling stock and components worldwide, building on its success with Vande Bharat trains.





RBI & COMMERCE MINISTRY DISCUSS LIBERALISATION OF FEMA FOR E-COMMERCE EXPORTS

Director General of Foreign Trade (DGFT), Santosh Kumar Sarangi, revealed that the Commerce Ministry is engaged discussions with the Reserve Bank of India (RBI) regarding the liberalization of Foreign Exchange (FEMA) Act Management facilitate guidelines eto commerce exports.




