# INDIAN IT SERVICES INDUSTRY EYES 3-5% GROWTH IN FY25: ICRA REPORT

The Indian IT services industry is anticipated to witness a modest revenue growth of 2 percent in the initial three-quarters of FY24, with expectations to maintain a restrained trajectory ranging from 3-5 percent in FY25, according to a recent report released by ICRA on Monday

This marks the second consecutive year where the credit rating agency has projected growth rates within the 3-5 percent range for the Indian IT sector.





The agency projects stable operating profit margins around 21–22% in FY25 for the IT sector.

Growth is expected to improve when macroeconomic challenges ease. Despite a slowdown in the US, companies maintain strong order books. Top firms like TCS report high total contract values. Hiring has been limited due to demand moderation.

Industry players are predicted to maintain financial strength with dividends, buybacks, and investments.

The importance of technology spending in corporate strategies post-pandemic is highlighted.






