



# AEPC TARGETS \$40 BILLION GARMENT EXPORTS FROM INDIA BY 2030

In a recent announcement on Tuesday, the Apparel Export Promotion Council of India (AEPC) has outlined pivotal strategies to propel the country towards achieving a remarkable milestone - a USD 40 billion garment exports target by 2030.

Emphasising the significance of bolstering production capacities and enhancing workforce skills, AEPC Chairman Sudhir Sekhri articulated a roadmap towards realising this ambitious goal.



Sekhri addresses challenges in the garment industry, emphasizing the scarcity of skilled workers and the need to ramp up production capacities to meet export targets.

AEPC commits to bridging the skills gap, enhancing manufacturing capabilities, and upskilling the workforce to align with industry demands.

Despite efforts, the annual generation of 150,000 skilled workers falls short of demand.





# GOLD JEWELLERY EXPORTS SURGE DESPITE DECLINE IN INDIA'S GEMS & JEWELLERY SECTOR

In February 2024, India's gems and jewellery sector experienced a significant decline in exports, marking a 12.66 per cent decrease year-on-year, according to recent data released by the Gem Jewellery Export Promotion Council (GJEPC).

However, amidst this downturn, there is a glimmer of hope as gold jewellery exports surged by 16.43 per cent, showcasing resilience in this segment of the industry.





In February 2024, gold jewellery exports reached USD 821.55 million, showing growth despite challenges in the gems and jewellery sector.

Expert Navneet Dubey highlights the sector's adaptability.

Overall gems and jewellery exports declined to USD 3.05 billion, raising concerns about the trade gap.

Imports of gems and jewellery slightly increased to USD 2.26 billion, indicating domestic market demand.

Strategic measures are needed to address challenges in India's gems and jewellery industry.




