





INDIAN EXPORTERS FACE ISSUES WITH UK'S NEW TRADE SCHEME

The UK's replacement of the Generalised Scheme of Preferences (GSP) with the Developing Countries Trading Scheme (DCTS) is causing some confusion for Indian exporters due to differences in product descriptions.

The Federation of Indian Export Organisations (FIEO) is working to match Indian product codes with those used by the UK under DCTS to provide clarity to exporters, according to sources.

"Indian exports worth \$2.5 billion annually were entitled for GSP benefits in the UK. It's crucial we resolve the product identification issues under DCTS," a source revealed to businessline.



The UK introduced the DCTS with duty cuts similar to GSP but with changes in origin declaration.

Indian exporters must map 8-digit codes to UK's 12-digit codes for products like leather, carpets, chemicals, steel, and textiles.

Compliance with DCTS rules, including ROO criteria and self-certified origin declarations, is necessary for tariff concessions in the UK.





INDIAN RICE EXPORTERS FACE CRIPPLING TAX DEMANDS ON PAST SHIPMENTS

India's rice export industry is facing a severe crisis as the customs department has issued notices demanding payment of duty differentials on rice exported over the past 18 months.

This unprecedented tax demand could potentially cripple rice shipments from the world's biggest rice exporter, reported Reuters.





The Indian government imposed a 20% export duty on white rice in 2022 and on parboiled rice in 2023 to control domestic prices before elections.

Initially based on Free on Board value, exporters must now consider transaction value for duty calculation.

Exporters are now required to pay any duty difference retroactively, causing financial strain on the industry.




