




YEN DEPRECIATION NOT A CONCERN FOR INDIAN EXPORTS TO JAPAN: FIEO

The recent depreciation of the Japanese yen is not anticipated to adversely affect India's exports to Japan, clarifies the Federation of Indian Export Organisations (FIEO).

While the weaker yen may elevate the costs of Indian imports of electronics, machinery, and auto components, it is unlikely to impact India's exports to Japan significantly, as stated by FIEO's Director General and CEO, Ajay Sahai. Sahai explains that India primarily exports goods like apparel and marine products to Japan, which are not produced domestically by Japanese companies, thus avoiding direct competition with domestic manufacturers.



The weakening yen may increase prices for Japanese consumers but not reduce demand. Indian companies with yen borrowings may face challenges, but hedging can help. The yen's decline is attributed to the Bank of Japan's policy change. It may boost Japanese exports' competitiveness.

Indian companies might increase imports from Japan due to the depreciating yen. The engineering sector's exports to Japan are expected to be minimally affected.





INDIA'S RICE EXPORT PRICES SURGE AMIDST HIGHER DUTY ON RICE SHIPMENTS

Rice export prices increased in top exporter India this week as traders factored in higher duty on rice shipments. Meanwhile, demand remained lackluster in rival supplier Thailand.

India's 5 percent broken parboiled rice prices rose to USD 550-USD 558 per ton from USD 543-USD 550 last week.





Rice prices surged to USD 560, driven by India's export duty on parboiled rice.

Indian exporters face challenges with duty differentials. In Thailand, prices eased due to currency factors.

Vietnam's prices remained stable. Bangladesh plans private rice imports despite high prices.






