



# SENIOR OFFICIALS & EXPORTERS TO DISCUSS RED SEA CRISIS IMPACT ON MARCH 8

Officials from various ministries and exporters are set to convene on March 8 to address the challenges faced by exporters due to the Red Sea crisis, as announced by an official.

This will mark the third meeting dedicated to tackling the ramifications of the Red Sea crisis, which began in November when Yemen-based Houthi rebels targeted ships in the Red Sea and surrounding waters amid the Israel-Hamas conflict, reported BS.



Ministries' representatives, led Commerce Secretary Sunil Barthwal and Minister Piyush Goyal, will meet on to address challenges March including high transportation costs and credit flow for exporters. The exporting community seeks government intervention in freight rates due to the Red Sea crisis. Export Credit Guarantee Corporation aims to support Indian exporters amid a decrease of 4.89% in export figures to USD 353.92 billion from April-January this fiscal year.





# INDIA CONSIDERS QUOTA-BASED DUTY CONCESSIONS ON GOLD IMPORTS FROM SWITZERLAND UNDER EFTA AGREEMENT

India is contemplating granting quota-based duty concessions on gold imports from Switzerland under the proposed free trade agreement with the European Free Trade Association (EFTA) to foster trade relations.

Officials have revealed to BS that alongside this initiative, India has also sought a substantial investment commitment of USD 50 billion within the first decade post the agreement's implementation, followed by another USD 50 billion over the subsequent five years.





India aims to strengthen trade ties with the EFTA (Iceland, Liechtenstein, Norway, Switzerland).

Switzerland's request for duty concessions on gold imports, which form a significant portion of India's imports from Switzerland, is crucial. Discussions on extending quota-based concessions to EFTA, similar to those with the UAE, are ongoing to ensure investment stability.

Despite current duties, gold imports to India surged by 30% to USD 38 billion. These negotiations reflect India's strategic trade approach and can greatly impact the country's economic landscape.




