## INDIAN AUTO EXPORTS FACE DECLINE AMIDST Geopolitical tensions: Siam

India's automobile exports remained under considerable stress during the last financial year due to multiple geopolitical conflicts and currency issues in key markets, according to Vinod Aggarwal, President, Society of Indian Automobile Manufacturers (SIAM).

Aggarwal cited the ongoing Russia-Ukraine war and Israel-Gaza conflicts as major factors hampering Indian auto exports, reported ETAuto.



India's auto exports are affected by geopolitical conflicts and forex issues in key markets, including due to the Red Sea crisis leading to longer shipping routes and increased costs.

Despite challenges, there is optimism for a rebound in exports, especially for two-wheelers, in the current fiscal year. Major export destinations include Latin America, Southeast Asia, Africa, and the Middle East.




## GOVT MULLS SOLAR CELL INCLUSION IN ALMM TO CURB Reliance on Chinese Imports

The Indian government is considering expanding its "Approved List of Models and Manufacturers (ALMM)" policy to include solar cells in addition to solar modules, according to government officials.

The move aims to reduce reliance on Chinese imports and promote domestic solar cell manufacturing, reported Mint.

The ALMM currently restricts the use of certain imported solar modules in governmentsupported projects. By adding cells to the approved list,





India considers including cells under ALMM but faces challenges due to low domestic cell manufacturing capacity. The country heavily relies on imported cells, mainly from China. Analysts suggest it may take 24 to 30 months to build sufficient domestic capacity.

The proposed cell policy aims to support India's goal of 500 GW of non-fossil power by 2030, emphasizing the localization of solar manufacturing to reduce dependence on China.




