USD 6.69 TN ECONOMY, USD 1.58 TN EXPORTS: MODI'S AMBITIOUS VISION FOR 2030

Prime Minister Narendra Modi has set his sights on an ambitious economic transformation plan for India by the year 2030.

He has directed officials to draft a blueprint aimed at nearly doubling the size of India's economy to a staggering USD 6.69 trillion in nominal terms from the current level of USD 3.51 trillion.

The BJP government's vision to radically expand the economy and exports over the next six years was revealed in an official document accessed by Reuters.



The document lays the groundwork for high-level government discussions. Prime Minister Modi aims for India's self-reliance in the next decade and to elevate the economy to the world's third-largest.

Goals include increasing per capita income, doubling exports to USD 1.58 trillion by 2030, and enhancing social development targets like literacy rate, unemployment, and labor force participation.



INDIA OPENS DOOR FOR TESLA PLANT AFTER EV IMPORT DUTY SLASH

India has slashed import duties on electric vehicles (EVs), paving the way for Tesla to potentially manufacture its EVs in the country.

The government is now looking to Elon Musk's Tesla to unveil its investment plans for the nation. In an interview, Rajesh Kumar Singh, Secretary of the Department for Promotion of Industry and Internal Trade (DPIIT), stated, "We will help them out in terms of giving them the contacts at state level.





A recent policy aims to boost domestic EV manufacturing, granting tax concessions to companies investing at least \$500 million and initiating local EV production within three years. Expectations are set for a significant increase in EV penetration, with estimates suggesting up to 15% adoption by 2030. While electric two-wheelers have led India's EV market, the passenger EV segment is rapidly growing. Tesla, seeking lower import taxes, is reportedly considering a \$2-3 billion factory investment and plans to increase auto component sourcing from India to \$15 billion. With favorable policies and a promising market, the onus is on Tesla to finalize its manufacturing plans in India






