

ANTI-DUMPING DUTIES IMPOSED ON SODIUM CYANIDE

The Directorate General of Trade Remedies (DGTR) has proposed imposing anti-dumping duties on sodium cyanide imports from China, the European Union, Japan, and South Korea for a period of five years.

The regulatory authority has suggested imposing a definitive anti-dumping duty that is the lower of either the calculated dumping margin or the margin of injury, ranging from USD 13 to USD 554 per metric ton.

The recommendation follows an anti-dumping investigation initiated on March 31, 2023 based on a petition filed by domestic producers Hindustan



investigation DGTR found that The dumped sodium cyanide imports caused harm to the domestic industry capacity expansions despite and investments. Unfairly priced imports led prices, production suppressed to declines, and financial losses. Antidumping measures were recommended to address the situation the domestic sodium and support cyanide industry.



COMMERCE MINISTRY EYES EXTENSION OF INTEREST EQUALISATION SCHEME TO DRIVE EXPORT GROWTH

The Commerce Ministry is likely to seek a substantial five-year extension of the interest equalisation scheme on pre- and post-shipment rupee export credit, an official source revealed. This move aims to bolster India's export performance and fuel growth in the sector.

The current iteration of the scheme, introduced on April 1, 2015, is set to expire on June 30, 2024. Initially intended to run for five years until March 31, 2020, the scheme has already received one extension.





The ministry plans to extend the interest equalisation scheme for exporters for five years to support them with affordable credit facilities

ensuring competitiveness in global markets and boosting the country's outbound shipments.




