Terms & Conditions for Participation in Group Delegations to the trade Shows (Vietnam & Uzbekistan), arranged by AECCI-

- Participation will be confirmed on a first-come, first-served basis, subject to fulfillment of eligibility and completion of documentation and payments.
- b. The space allotted to approved participants is to be used exclusively by them for the display of their own products/services. Subletting or sharing of space is strictly prohibited. Violation of this clause may result in: Cancellation of the space allotted, Forfeiture of space rent, security deposit, and any grant/subsidy (if applicable) and Debarment from future participation in AECCI events
- c. AECCI shall not be held responsible for the turnout of buyers, importers, or agents at the exhibition/fair. No claims for refunds, reimbursements, or compensation shall be entertained in this regard.
- d. Visa assistance will be provided only to regular employees, directors, partners, or proprietors of the participating company. The issuance of a visa is at the sole discretion of the host country's embassy, and AECCI does not guarantee approval.
- e. The participating representative must **return to India after the event** and provide proof of departure and arrival as required. This may be needed for processing grants or subsidies (if applicable).
- f. A AECCI shall not be responsible for: The **transportation** of exhibits, **Damage or loss** during transit or at the venue and **Customs clearance** of samples, promotional materials or goods
- g. Participants must arrange for **unpacking**, **installation**, **and display** of their exhibits at their own cost. Booths must be set up and manned as per the event schedule.
- h. Participants are required to submit a detailed feedback form after the event, including: Enquiries received, Orders booked, Business potential generated, as this is mandatory for processing of any financial support or reporting to government bodies.
- i. All expenses related to international and domestic travel, accommodation, meals, medical treatment, insurance, and local transport are to be borne by the participants. AECCI will not provide reimbursements under any circumstances.
- j. In the event of **non-payment or default**, AECCI reserves the right to: Cancel participation without notice, Withhold any dues or grants, Report the default to relevant authorities and Debar the participant from future events
- k. Participants are expected to maintain professional conduct and represent India and their company responsibly. Any behavior deemed inappropriate by AECCI or the event organizers may lead to immediate expulsion from the event at the participant's own cost.
